As we are responsible for any damage to your car while it is in our custody, so too are you and/or your insurance legally and financially responsible for our Loaner Vehicles.

I further agree not to allow anyone other than me and any additional drivers listed on the Agreement to drive the Loaner Vehicle. I agree to redeliver the Loaner Vehicle to Accomplished Auto on or before the Return Date in as good mechanical and physical condition as when it was loaned to me, or to pay Accomplished Auto immediately the cost and expense for any repairs necessary to restore the Loaner Vehicle to the same condition as when I received it.

In the event of any accident or damage to or involving the Loaner Vehicle, I will notify by telephone immediately after any such accident and confirm the same in writing to Accomplished Auto within twenty-four (24) hours thereafter, including in such written notification a full and complete report thereof (including, without limitation, complete copies of any reports prepared by law enforcement concerning the same).

I also agree to promptly reimburse Accomplished Auto upon demand for any damage, cost or expense in connection therewith regardless of whether the same is or should be whatsoever for the repair of the Loaner Vehicle without Dealer's prior written consent; that I will bear all expenses incidental to the repair and maintenance caused by the misuse or abuse of the Loaner Vehicle while in my possession and that I will pay Dealer for all claims and demands, including, without limitation, parking tickets, speeding tickets, tolls, arising or resulting from the use, storage and/or repair of and to the Loaner Vehicle during the operation of this Agreement and/or my custody of the Loaner Vehicle.

I expressly understand that I do not have the permission of Accomplished Auto to operate the Loaner Vehicle either outside the State of New Hampshire and/or beyond the time specified for its return, such operation being without authorization by Dealer.
